Rules and Regulations Governing Use of Parks



THESE RULES AND REGULATIONS WERE ADOPTED FOR THE SOLE PURPOSE OF IN-THE MAXIMUM ENJOYMENT. WITH SAFETY AND COMFORT, OF RESIDENTS USING PARK THE THE PARK COMMISSIONERS PROPERTY. ASK YOUR COOPERATION IN COMPLYING THESE RULES AND REGULATIONS SO THAT EVERYONE USING THE WILL HAVE A SAFE AND ENJOYABLE TIME.

## MATTITUCK PARK DISTRICT

## Rules and Regulations Governing Use of Parks

WHEREAS, pursuant to provisions of Chapter 924 of the Laws of 1941 of the State of New York, the Park Commissioners have the authority to adopt by resolution, rules and regulations with respect to the use and enjoyment and the maintenance of order on all park property:

RESOLVED, the following rules, regulations and provisions shall apply to all of the Mattituck Park District properties.

- 1. USE OF PARKS Use of parks shall be restricted to residents and/or owners of taxable real property residing in the Mattituck Park District. Any resident shall be allowed a reasonable number of guests as long as said guests accompany him while using the Park District Property.
- 2. OPENING AND CLOSING The park shall be opened and closed at the time and hour designated by the Park Commission. No person shall use the park at a time or an hour other than that designated. Opening and closing time for the various facilities will be posted for the convenience of the park district. No overnight parking, housing or camping shall be allowed except

under special permit obtained from the Park Commissioners.

3. MINORS — No person under ten (10) years of age shall be admitted to the park unless accompanied by an adult who shall assume full responsibility for his safety and conduct.

- 4. PARKING Vehicles entering any Park District property shall enter only at the designated entrances and leave only through designated exits. Parking of vehicles is permitted only in designated areas.
- 5. LOSS, DAMAGE AND THEFT The Park District will not be responsible for loss, damage or theft to cars and their contents, nor to private property. Such loss, whether inside of buildings or on the grounds of the park, shall be the patrons' responsibility.
- 6. PICNICS AND OUTINGS The Park Commissioners shall designate the areas to be occupied and shall regulate the use of recreation facilities so as to prevent congestion and shall distribute patrons of the park over the park area in order to insure the maximum use of the park area, and in behalf of the comfort of said patrons. All organized picnics and outings shall first obtain a special permit from the Park Commissioners.
  - 7. FIRES No person shall kindle, build,

maintain or use a fire anywhere within the park properties except in designated areas so marked or under a special permit obtained from the Park Commissioners.

- 8. GAMES No person shall throw or use any type of ball, bean bag or other object, play any ball game or roller skate, except in such places designated for such use, nor engage in skateboard, go-cart or motor scooter riding, toy aviation, kite flying or model boating.
- 9. CAMPING No person shall tent or camp or erect or maintain a tent, shelter or camp in the park, except under special permit obtained from the Park Commissioners.
- 10. ANIMALS No person owning or being custodian or having control of any animal shall cause or permit such animal to enter the park and any such animal found at large may be impounded. Any animals seized as above provided will be delivered to the public pound.
- 11. SWIMMING AND BATHING Swimming and bathing is permitted only in the water area delineated or enclosed by floating lines of markers. No person shall launch, land, moor or operate any boat or vessel in, through or across the swimming and bathing area. No fishing is permitted in the swimming and bathing area.

Areas in front of lifeguard stands marked with

green flags are to remain clear of people, blankets, umbrellas, and any other obstruction that might interfere with the performance of lifeguard duties.

In severe weather or under other dangerous conditions, lifeguard shall have the authority to limit bathing and swimming.

- 12. CONCESSIONS The selling, vending or offering for sale of any wares, foodstuffs or merchandise upon the park grounds is strictly prohibited except where in such case and instance the Park Commissioners have issued a permit therefor.
- 13. REFUSE AND GARBAGE No person shall throw, break, cast, lay or deposit bottles, cartons, papers, wrappers, garbage or refuse of any kind or nature on the Park District property but shall place the same in containers provided therefor.
- 14. ADVERTISING No person shall post, paint, affix, distribute, hand out, deliver, place, cast or leave about, any bill, billboard, placard, ticket, handbill, circular or advertisement; display any flag, banner, transparency, target, sign, placard or any other matter for advertising purposes; or operate any musical instrument or drum or cause any noise to be made for advertising purposes, or for the purpose of attracting attention to any exhibition, performance, show or other pur-

pose except as authorized by the Park Commissioners.

- 15. MEETINGS, EXHIBITIONS, PARADES, RACING, ETC. - No person shall erect any structures, stand or platform, hold any meeting, perform any ceremony, make a speech, address or harangue; exhibit or distribute any sign, placard, notice, declaration or appeal of any kind or description; exhibit any dramatic performance, or the performance in whole or in part of any interlude, tragedy, comedy, opera, ballet, play, farce, dancing, entertainment, motion picture, public fair, circus, juggling, ropewalking, or any other acrobatics, or show of any kind or nature; or run or race any horse, or other animal or being in or on a vehicle, race with another vehicle or horse, whether such race is founded on any stake, bet or otherwise; in the park except by permit. No parade, drill or maneuver of any kind shall be conducted, nor shall any procession form for parade or proceed in the park without a permit from the Park Commissioners.
- 16. PROTECTION OF PROPERTY No person shall injure, deface, displace, remove, fill in, raise, destroy or tamper with any drive, path or walk; take up, remove or carry away trees, shrubs, turf or any material or substance; remove or destroy any structure, building or any appurtenances connected with the park or any other property or equipment, real or personal, owned by the Park District, or under the jurisdiction and

control of the Park District.

17. FIREARMS, FIREWORKS AND EX-PLOSIVES — No person shall have or carry, whether or not concealed upon his person, any pistol or revolver, rifle, shotgun or any air-gun, spring gun or other weapon in which the propelling force is a spring or air, except when so authorized by law.

No person, except in the performance of official duties shall discharge a firearm, air-gun, or other instrument or weapon in the park in such a manner that a projectile enters or is likely to

enter the park.

No person shall bring into or have in said park any explosives or fireworks, including any substance, compound, mixture or article having properties of such a character that alone or in combination or contiguity with other substances or compounds may decompose suddenly and generate sufficient heat, gas, or pressure, or any or all of them to produce rapid flame, combustion or administer a destructive blow to surrounding objects.

- 18. CONDUCT OF PATRONS Every person shall conduct himself in an orderly manner and shall endeavor to cause no discomfort or inconvenience to any person or patron. Gambling is strictly prohibited in all areas of the park.
- 19. PERMITS A permit, license or identification tag to do any act shall authorize the same

only insofar as it may be performed in strict accordance with the terms and conditions of said permit, license or identification tag. Any violation by its holder shall constitute ground for revocation by the Park Commissioners or their authorized representative.

- 20. CONSTRUCTION AND SCOPE OF RULES AND REGULATIONS Any term in the singular shall include the plural. Any term in the masculine shall include the feminine. Person shall be construed to mean natural person, corporation, company, association or co-partnership. The term "park" unless specifically limited, shall be deemed to include all park areas, spurs, open spaces, entrances, approaches, playgrounds, athletic fields, buildings and other areas and facilities under the jurisdiction of the Mattituck Park Commissioners.
- 21. INDIVIDUAL PARK RULES In addition to the foregoing rules and regulations, various Mattituck Park properties are subject to additional rules and regulations covering the use of a particular park. Such rules and regulations may be obtained from the Park Commissioners or their authorized representative.
- 22. VIOLATIONS The violation of any provision of the rules and regulations herein shall be cause for eviction from the park properties and revocation of all park privileges as well as any criminal penalty as a result of such violation.

23. DATE OF RULES AND REGULATIONS

— These rules and regulations shall take effect immediately.
